

## **ARPC RIFLE CONSIGNMENT PROGRAM**

- 1. Rifles may be consigned only to paid-up voting members. Consignment privilege is not a "right" conferred with membership but depends on the confidence that the rifle will be well cared for and will actually be put to use to improve marksmanship. That determination is to be left to the discretion of the Consignment Coordinator who serves at the pleasure of the club president. A rifle may be recalled if it is determined that the rifle is not being used on a regular basis, being used in an unsafe manner or is not cared for properly;**
- 2. Consignment is to be for a period not to exceed 6 months and, in every case, not to be for a period that extends beyond June 30th of each year, the date that marks the end of the club fiscal year and when memberships officially expire. Guns returned on or before June 30th may be reconsigned to the same member provided all is in good order and dues are paid in full for the next year;**
- 3. Rifles may be returned before the consignment period expires and every effort is to be made to make sure the rifles are not returned late in order for the member to retain consignment eligibility. All rifles are to be returned in as-issued condition, thoroughly cleaned and ready for use;**
- 4. Members are responsible for the condition of the rifle while in their possession. Any damage or loss must be reported promptly by the member to the Coordinator. Any rifle that is lost or is damaged through neglect or improper treatment is the responsibility of the member and the member is responsible to make good any loss to the club. Estimated rifle replacement value is to be recorded on the consignment form and this is the amount due the club. The member is encouraged to obtain an insurance rider on their homeowners policy for the rifle;**
- 5. Consigned rifles may not be loaned to any other person but are to remain in the possession and custody of the members to whom the rifle was consigned. Rifles are to be placed in secure storage at the members' residences and to be made inaccessible to unauthorized use.**
- 6. The consignment form is on the back of this document and is to be completed in duplicate with one copy staying with the Coordinator and the other going with consignee. Besides the gun's identification, the form will document when the rifle was borrowed, when it is due to be returned and when it was actually returned. The completed form is to be kept by the member in a safe place and returned with the rifle for record purposes. The Coordinator will record the date when the rifle was returned and the member will retain the signed form as evidence that the rifle was returned on time and in good order. The signed form is a legal claim to the rifle and the rifle is the legal property of the ARPC and can be reclaimed by the ARPC at any time;**
- 7. Rifles are to be exchanged at a place and time convenient to the Coordinator. The member is advised to provide sufficient advance notice for pick-up and return;**
- 8. Any rifle that is reported as lost, stolen or missing and cannot be returned to the Coordinator will be reported to law enforcement. These guns are being used for the purpose of promoting marksmanship. There is documentation that identifies the club as the last owner of record. If one of these guns ever surfaced in the course of a criminal investigation, the paperwork would lead directly to the club's doorstep and the club would need to show due diligence in their storage and consignment and the timely reporting of missing guns.**
